

Hollywoodbets & Blu Voucher Competition

TERMS AND CONDITIONS

04 September – 02 October 2025

Customers stand a chance to win a Sportswear Voucher or their share of R50 000 in Cash or Betting Vouchers.

1. To qualify, customers must purchase a Blu Voucher to the value of R50 or more and redeem it into their Hollywoodbets account.
2. The Campaign runs from **04 September – 02 October 2025**.
3. Participants must be 18 years or older. Deposits made by persons under 18 will be disqualified.
4. Forty winners will be selected randomly to either win a sportswear voucher, cash, or betting voucher.
5. The winners will be selected randomly via draws from all qualifying deposits made during the promotional period.
6. Sportswear vouchers will be sent digitally to the winners' email accounts within 14 working days.
7. Cash and betting vouchers will be loaded into the winners' Hollywoodbets accounts.
8. The draws will take place at the Hollywoodbets Team Support Office, supervised by an Internal Auditor, on the dates below:
 - **Draw 1: 11 September** – 3x R2 500 sportswear vouchers, 2x R1 000 BV, 5x R2 000 Cash
 - **Draw 2: 18 September** – 2x R2 500 sportswear vouchers, 3x R1 000 BV, 5x R2 000 Cash
 - **Draw 3: 25 September** – 3x R2 500 sportswear vouchers, 2x R1 000 BV, 5x R2 000 Cash
 - **Draw 4: 03 October** – 2x R2 500 sportswear vouchers, 3x R1 000 BV, 5x R2 000 Cash
9. Entries are unlimited; however, a person may not win more than one prize during the promotional period. One deposit equals one entry.
10. Betting Vouchers must be turned (staked) once at odds of 5/10 (0.5 decimal) or greater before withdrawing.
11. The winners will be notified via a call or direct push message.

12. The competition is valid for all Hollywoodbets customers who hold an online betting account.
13. The prizes are not transferable and may not be changed or exchanged in any way.
14. If a selected prize cannot be sourced, Hollywoodbets reserves the right to replace it with another prize of equal value.
15. Winners must have a verified Hollywoodbets account (FICA-compliant) to claim their prize.
16. Hollywoodbets will attempt to call the winner up to three (3) times. If the winner does not answer after three (3) attempts, Hollywoodbets reserves the right to redraw a new winner.
17. The promotion is open to all Hollywoodbets customers who hold an online betting account.
18. Hollywoodbets and Blu Voucher will not be liable for any additional costs once the handover is complete.
19. Hollywoodbets reserves the right to amend, suspend, or cancel the promotion if necessary, due to unforeseen circumstances.
20. Hollywoodbets' decision regarding the promotion is final, and no further correspondence will be entered into.
21. There are no entry fees to participate in this promotion. Data costs, or any other costs incurred by an entrant in the ordinary course of business, will apply during the promotion period.
22. It is the responsibility of all entrants to ensure that their entry is received by Blu Voucher prior to the end of the promotion period. Any entries not received during the promotion period will not be eligible to participate, regardless of the reason.
